ORDINANCE NUMBER O- 17857 (NEW SERIES)

ADOPTED ON NOV 02 1992

AN ORDINANCE OF THE CITY OF SAN DIEGO, CALIFORNIA, TEMPORARILY EXEMPTING AREA CONGREGATIONS WHICH PARTICIPATE IN THE INTERFAITH SHELTER NETWORK FROM THE REQUIREMENT OF A CONDITIONAL USE PERMIT (CUP) WHEN EXPANDING THE NUMBER OF HOMELESS SERVED FROM 12 TO 20.

WHEREAS, approximately 130 congregations on a county-wide basis participate in the Interfaith Shelter Network; and

WHEREAS, these congregations serve over 500 homeless individuals on an annual basis by providing shelter beds at no cost to the guests; and

WHEREAS, the City and County have formed a partnership in serving the homeless by funding the Interfaith Shelter Network and have done such since 1986; and

WHEREAS, it is estimated that there are presently between 5,000 and 7,000 homeless within the City of San Diego; and

WHEREAS, many of the 5,000 to 7,000 do not have adequate shelter on any given night; and

WHEREAS, religious congregations have a long history of providing charitable services to the poor and needy; and

WHEREAS, the City of San Diego recognizes these facts and encourages the Interfaith Shelter Network; and

WHEREAS, an amendment to Conditional Use Permit for each congregation would be unnecessary, cumbersome and time consuming for the congregations; and

WHEREAS, the City Council, in order to encourage congregations to provide shelter for the homeless has determined to remove the requirement for an amendment to existing Conditional Use Permits where congregations wish to increase the number of persons served from a maximum of 12 up to a maximum of 20; NOW THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The Zoning Administrator may administratively approve increasing the number of persons served at area congregations from 12 to 20 when area congregations participate in the Interfaith Shelter Network and have complied with normal building safety and applicable fire codes and have obtained Conditional Use Permits which already allow shelter beds for up to 12 persons.

Section 2. Area congregations which have previously applied for and received Conditional Use Permits in conjunction with participating in the Interfaith Shelter Network are hereby authorized to expand from 12 to 20 individuals served providing they are meeting the other conditions of said Conditional Use Permits.

Section 3. Any congregation with a Conditional Use Permit which violates applicable building safety, fire and other codes may have its Conditional Use Permit terminated by the City giving a 30-day notice.


Section 4. This ordinance supersedes the Conditional Use Permit requirements contained in the Municipal Code but only to the extent this ordinance is inconsistent with the existing

Municipal Code provisions.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and shall expire five years from its effective date, unless earlier rescinded by the City Council.
