WHEREAS, one of the recommendations was to increase City of San Diego license fees notwithstanding what the dog license fees established by the County Code of the County of San Diego might be; and

WHEREAS, the Animal Control Blue Ribbon Panel recommended an additional unaltered license fee of \$0.50 per year to be used to establish a low cost spay/neuter program in The City of San Diego; and

WHEREAS, after a hearing on October 5, 1992, the City
Council approved a lower fee increase than contained in City
Manager's Report No. 92-298 and approved the Blue Ribbon Panel's
recommendation for an additional unaltered license fee of \$0.50
per year to provide a spay/neuter program; and

WHEREAS, the City Council wishes to establish in the San Diego Municipal Code the dog license fees to be charged in the City of San Diego effective January 1, 1993; NOW, THEREFORE,
