

ORDINANCE NUMBER O- 17860 (NEW SERIES)

ADOPTED ON NOV 10 1992

AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 4,
OF THE SAN DIEGO MUNICIPAL CODE BY ADDING
SECTION 44.0322 RELATING TO DOG LICENSE FEES.

WHEREAS, the City Manager issued Report No. 92-298 on October 1, 1992 with recommendations concerning animal control services in The City of San Diego; and

WHEREAS, one of the recommendations was to increase City of San Diego license fees notwithstanding what the dog license fees established by the County Code of the County of San Diego might be; and

WHEREAS, the Animal Control Blue Ribbon Panel recommended an additional unaltered license fee of \$0.50 per year to be used to establish a low cost spay/neuter program in The City of San Diego; and

WHEREAS, after a hearing on October 5, 1992, the City Council approved a lower fee increase than contained in City Manager's Report No. 92-298 and approved the Blue Ribbon Panel's recommendation for an additional unaltered license fee of \$0.50 per year to provide a spay/neuter program; and

WHEREAS, the City Council wishes to establish in the San Diego Municipal Code the dog license fees to be charged in the City of San Diego effective January 1, 1993; NOW, THEREFORE,

SEC. 44.0322 DOG LICENSE FEES


Effective January 1, 1993 The City of San Diego dog license fees for altered and unaltered dogs shall be:

	6 MONTHS	1 YEAR	2 YEARS	3 YEARS
ALTERED	\$ 6.00	\$10.00	\$17.00	\$23.00
UNALTERED	\$16.25	\$25.50	\$42.00	\$54.50

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
