ADOPTED ON NOV 23 1992

AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 2,
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SECTIONS 92.0201 and 92.0207 RELATING TO THE
ELECTRICAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Chapter IX, Article 2, of the San Diego
Municipal Code be and the same is hereby amended by amending
Sections 92.0201 and 92.0207.

SEC. 92.0201 Permits Required

A. through D. [No changes.]

E. The provisions of Section 111.1306 supplement
the provisions of this Division.

SEC. 92.0207 Application for Permit

A. Application for a permit, describing the work
to be done, shall be made in writing to the Building
Official. The application shall be accompanied by such
plans, specifications, and schedules as may be
necessary to determine whether the installations as
described will be in conformity with the requirements
of this Article. If it shall be found that the
installation as described will conform with the
requirements of this Article, and if the applicant has
complied with all provisions of this Article, a permit
for such installation shall be issued in accordance


with Section 111.1306(b). The issuance of the permit shall not be taken as permission to violate any of the requirements of this Article.

B. through D. [No changes.]

Section 2. This ordinance shall take effect and be in force on January 4, 1993. The provisions of this ordinance shall not be applicable within the Coastal Zone until the thirtieth (30th) day following the date the California Coastal Commission unconditionally certifies this ordinance as a local coastal program amendment or January 4, 1993 whichever occurs last.

AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 91.0201 and 91.0207 RELATING TO THE ELECTRICAL CODE.

This ordinance amends the provisions of Chapter IX, Article 2, to be consistent with the provisions of Chapter XI. The amendments to Chapter IX, Article 2, integrates the procedural requirements that were created by the adoption of Chapter XI and provides the user of Chapter X with the applicable cross references to Chapter XI.
