ADOPTED ON NOV 23 1992

AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 3,
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SECTION 93.0301 RELATING TO PERMITS.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Chapter IX, Article 3, of the San Diego
Municipal Code be and the same is hereby amended by amending
Section 93.0301.

SEC. 93.0301 Plumbing Permits Required

(a) No plumbing system or part thereof shall be
installed within or on any building, structure, or
premises, nor shall any alteration, addition, or
replacement be made in any such existing plumbing
system unless a permit therefor has first been issued,
in accordance with Section 111.1306(b), by the Building
Inspection Department to the persons performing such
work except as stated otherwise in Section 93.0303.

(b) through (e) [No changes.]

(f) The provisions of Section 111.1306 supplement
the provisions of this Division.

Section 2. This ordinance shall take effect and be in force
on January 4, 1993. The provisions of this ordinance shall not
be applicable within the Coastal Zone until the thirtieth (30th)
day following the date the California Coastal Commission

unconditionally certifies this ordinance as a local coastal
program amendment or January 4, 1993 whichever occurs last.
