
BE IT RESOLVED, by the Council of The City of San Diego, that the low acceptable bids of 1. A & T SAW & LAWMOWER SHOP, 2. WESTERN TURF - SAN DIEGO, 3. GEORGE'S LAWN EQUIPMENT, 4. MASON'S SAW & LAWMOWER SERVICE, INC., 5. YANAGIHARA ENTERPRISES, INC. dba OUCHI NURSERY, 6. C.R. JAESCHKE, INC., 7. ZAGANI, INC. dba CLAIREMONT EQUIPMENT CO. and 8. SAN DIEGO TURF & IRRIGATION INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS EQUIPMENT AND ENGINE PARTS as may be required for a period of one (1) year beginning February 1, 1992 through January 31, 1993, per prices on file in the Purchasing Department as follows:

1. A & T SAW & LAWMOWER SHOP for Items 7, 10, 13, 14, 15, 27, 30 and 31; terms net 30, plus sales tax, with options to renew for four (4) additional one (1) year periods with no change in the percentage discount off list price.
2. WESTERN TURF - SAN DIEGO for Item 15; terms net 30, plus sales tax.
3. GEORGE'S LAWN EQUIPMENT for Items 1, 2, 3, 4, 6, 9, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25 and 26; terms net 30, plus sales tax, with options to renew for four (4) additional one (1) year periods with no change in the percentage discount off list price.
4. MASON'S SAW & LAWMOWER SERVICE, INC. for Items 8, 10 and 30; terms net 30, plus sales tax, with options to renew for four (4) additional one (1) year periods with option period

increases not to exceed 10% of prices in effect at the end of the prior contract period.

5. YANAGIHARA ENTERPRISES, INC., dba OUCHI NURSERY for Items 1, 2, 4, 6, 9, 16, 17, 18, 19, 21, 22, 23, 27 and 28; terms net 30, plus sales tax, with options to renew for four (4) additional one (1) year periods with option period increases not to exceed 10% of prices in effect at the end of the prior contract period.
6. C.R. JAESCHKE, INC. for Items 8, 11, 13, 14, 24, 28 and 31; terms 2% 20 days, plus sales tax, with options to renew for four (4) additional one (1) year periods with option period increases not to exceed 10% of prices in effect at the end of the prior contract period.
7. ZAGANI, INC. dba CLAIREMONT EQUIPMENT CO. for Items 5, 6 and 20; terms 2% 10 days, plus sales tax.
8. SAN DIEGO TURF & IRRIGATION, INC. for Items 1, 3, 7, 12 and 26; terms net 30, plus sales tax with options to renew for four (4) additional one (1) year periods with option period increases not to exceed 15% of prices in effect at the end of the prior contract period.
