BE IT RESOLVED, by the Council of The City of San Diego, that the low and low acceptable bids of 1. SAN DIEGO PLASTICS and 2. REID & CLARK are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of BLANK AND PRINTED PLASTIC PANELS as may be required for a period of one (1) year beginning November 1, 1991 through October 31, 1992, per prices on file in the Purchasing Department as follows:

1. SAN DIEGO PLASTICS for Section I, Blank Plastic Panels, for a total estimated cost of \$28,800.00; terms net 30 days plus sales tax, with an option to renew the contract for two (2) additional one (1) year periods with price increases not to exceed 10% of prices in effect at the end of each prior year.
2. REID & CLARK for Section II, Printed Plastic Panels, for a total estimated cost of \$12,240.00; terms net 30 days plus sales tax with an option to renew the contract for two (2) additional one (1) year periods with price increases not to exceed 5% of prices in effect at the end of each prior year.
