



BE IT RESOLVED, by the Council of The City of San Diego that the expenditure of an additional \$1,979.50 for the incorporation of a hard-top superstructure on a multi purpose rescue vessel for the Lifeguard Services Division, in accordance with the terms and conditions of Bid No. H1267/90, previously authorized by Resolution No. R-275447, adopted on April 16, 1990 by A.C. No. 9000821 is hereby authorized.

BE IT FURTHER RESOLVED, that the additional expenditure, not to exceed \$1,979.50.00, from Department No. 100, Fund No. 447, Organization No. 340, Object Account No. 6010, and Job Order No. 3400, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
