BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for SIDEWALK AND CURB REPLACEMENT ON VARIOUS CITY STREETS - FY 92 - C-7.

BE IT FURTHER RESOLVED, that the expenditure of \$200,000.00 from Gas Tax Fund 302191, is hereby authorized solely and exclusively for providing funds for said project and related costs.
