APPROVING PARCEL MAP OF W.O. NO. 900566.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Gary A. Lintvedt, Licensed Land Surveyor, entitled "Parcel Map W.O. No. 900566, being a division of all of Pueblo Lot 317 of the Pueblo Lands of San Diego, in The City of San Diego, County of San Diego, State of California, according to map by James Pascoe in 1870, filed in the office of the County Recorder of San Diego County, as Miscellaneous Map No. 36. Excepting therefrom the southeasterly 200.00 feet of the southwesterly 250.00 feet thereof, also excepting therefrom the northeasterly half of said Pueblo Lot 317," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the division of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication those portions of Parcels 1 and 2 marked "Reserved for Future Streets," as shown on this map, under the provisions of Section 66440 of the Government Code.


