Peters Company, Inc., for Genstar Development, Inc., as subdivider; said Amendment to Subdivision Improvement Agreement is on file in the office of the City Clerk as Document No. RR- 279221.

2. That the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by June 1, 1992, as provided in the Amendment to Subdivision Improvement Agreement.

3. That Performance Bond No. 3SM 771 005 00, issued by American Motorists Insurance Company, in the amount of \$476,034.00, is hereby accepted as the surety for the required improvements in the subdivision, is substituted as Exhibit C to

the agreement, and Performance Bond No. SC6441225, issued by The American Insurance Company, in the amount of \$1,904,138.00, is hereby released.
