WHEREAS, the alternative patrol capabilities are expected to enhance crime prevention and law enforcement efforts and further the development of innovative patrol activities; and

WHEREAS, the donation is valued at approximately one thousand two hundred dollars (\$1,200.00) with no requirement for matching funds and no maintenance costs for one (1) year;

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is authorized to accept a donation of two (2) mountain bicycles with assorted safety, convenience and repair equipment, a one (1) year maintenance package, and a car mounted rack from the San Diego Crime Commission for use as alternative patrol vehicles in the Department's Special Tactics of Policing (S.T.O.P.) program.
