BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a lease agreement with THE BOYS CLUB OF SAN DIEGO, INC., a nonprofit organization, d.b.a. BOYS AND GIRLS CLUB OF SAN DIEGO, for the operation of the William J. Oakes/Logan Heights Branch Boys and Girls Club on City-owned property located at 2930 Marcy Avenue, with the following basic conditions:

- Operator: Boys and Girls Club of San Diego
- Location: 2930 Marcy Avenue (NW corner of Marcy Avenue and 30th Street)
- Activities: Athletics, arts and crafts, indoor games, cooking classes, tutoring and homework assistance, and special events
- Term: Ten years, with an option to extend for an additional ten years if the property is adequately maintained during the initial term
- Rental: Six Hundred Dollars (\$600) per year
- Maintenance of Building: Provided by Boys and Girls Club of San Diego;


