WESTON, INC., to provide technical support during the drafting and negotiation of a service agreement for the City's Comprehensive Waste Management System project, under the terms and conditions set forth in the agreement, on file in the office of the City Clerk as Document No. RR- 279240, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.


BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$86,000 from the Waste Management Enterprise Fund, CIP No. 37-255.0 Materials Recovery Facility, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that it is contemplated that this action will ultimately be financed with tax-exempt securities and the funds herein sought will ultimately be financed with tax-exempt securities and the funds herein sought would be reimbursed with proceeds from the sale of such securities.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized, upon advice from the administering department, to transfer excess budget funds, if any, to the appropriate reserves.
