WHEREAS, the California State Commission on Police Officer Standards and Training (P.O.S.T.) desires the services of a police captain to serve in a nine (9) month P.O.S.T. fellowship position; and

WHEREAS, the San Diego Police Department is willing to provide the services of a police captain to serve in a nine (9) month P.O.S.T. fellowship position; and

WHEREAS, the P.O.S.T. fellowship position will be responsible for developing an action and implementation plan for over one hundred (100) recommendations resulting from a state-wide Training Issues Symposium on use of force, cultural awareness and supervisorial accountability; and

WHEREAS, the fellowship will not exceed nine (9) months and P.O.S.T. will provide sixty-nine thousand, eight hundred thirty-one dollars (\$69,831.00) to pay the salary of the police captain during the fellowship period; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is authorized to enter an agreement with the Commission on Police Officer Standards and Training (P.O.S.T.) in which the City will provide the services

of a police captain to fulfill a P.O.S.T. fellowship program for a period not to exceed nine (9) months at a cost of sixty-nine thousand, eight hundred thirty-one dollars (\$69,831.00) to P.O.S.T.
