RESOLUTION NUMBER R- 279264

ADOPTED ON JAN 13 1992

WHEREAS, the old federal courthouse, now known as the "Jacob Weinberger United States Courthouse," is a significant component of San Diego's civil and legal history; and

WHEREAS, the San Diego City Council is committed to the goal of preserving and utilizing buildings of historical significance; and

WHEREAS, the City of San Diego strongly supports the retention of the courts and related uses in the downtown areas, and views the court system as an integral part of our efforts to revitalize downtown and maintain a successful and vital business environment; and

WHEREAS, the General Services Administration, an agency of the federal government, has previously endorsed the proposition that the old federal courthouse be used for the bankruptcy courts; and

WHEREAS, the General Services Administration is now faced with increased renovation costs which threaten the restoration project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council strongly supports the proposition that the federal courthouse, the Jacob Weinberger United States Courthouse, be used for the bankruptcy courts to help meet the growing needs of the San Diego federal judicial system.

BE IT FURTHER RESOLVED, that the San Diego City Council encourages the General Services Administration to identify the necessary funding to allow the renovation to continue which will ultimately provide the impacted court system with a much needed facility.
