BE IT FURTHER RESOLVED, that the City Manager is further directed to re-evaluate the City's funding alternatives in order to add the Jewish Community Center under the Neighborhood Pride and Protection Program.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$115,000 from Fund No. 100, Community Park & Recreation Division budget, is hereby authorized, solely and exclusively to provide funds for the above agreement.
