
ADOPTED ON JAN 13 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Labor's Community Service Agency, Inc., to operate the Home Security Rehabilitation Program designed to assist the low income population, primarily in the Mid-City area of San Diego, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 279273, together with any reasonably necessary modifications or amendments thereto which do not increase project cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this Agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed fifty thousand dollars (\$50,000) from Fund No. 18527, and the expenditure of an amount not to exceed one hundred thousand dollars (\$100,000) from Fund No. 18523, are hereby authorized for the purpose of providing funds for the above project.
