RESOLUTION NUMBER R-279315

ADOPTED ON JAN 21 1992

WHEREAS, The City of San Diego Prearraignment Detention Facility is scheduled to open on May 1, 1992; and

WHEREAS, an increase in the number of misdemeanor arraignments is expected when the prearraignment facility is opened; and

WHEREAS, extended arraignment court hours may be required to accommodate the additional misdemeanor arraignments; and

WHEREAS, The City of San Diego also desires to allocate space in the prearraignment detention facility to hold persons convicted of misdemeanor offenses; and

WHEREAS, confinement of persons convicted of misdemeanor offenses in the City's prearraignment detention facility requires agreement under those circumstances in California Penal Code section 4004.5(b) which provide as follows: "A city may furnish facilities to be used for holding persons convicted of a public offense who have been transferred from the county jail by the sheriff due to crowded conditions upon such terms as may be agreed upon by the governing body of such city and the board of supervisors. The agreed terms may indicate that the facilities are to be provided free of charge to the county." NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, to request by copy of this resolution that the San Diego County Board of Supervisors examines and implements extended arraignment

court hours to accommodate the increase in number of misdemeanor arraignments expected when The City of San Diego Prearraignment Detention Facility is opened.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, to request by copy of this resolution that the San Diego County Board of Supervisors seeks the cooperation of the county sheriff and initiates action necessary to permit confinement of misdemeanants, sentenced by the San Diego Municipal Court, in the City's prearraignment detention facility.
