

RESOLUTION NUMBER R- 279319

ADOPTED ON JAN 21 1992

WHEREAS, ROBERT D. BARCZEWSKI, has requested an exchange of open space easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the acceptance by the City Manager of those deeds of ROBERT D. BARCZEWSKI, executed in favor of The City of San Diego, bearing date of December 13, 1991, conveying to said City open space easements in a portion of Parcel 4, Parcel Map 12337, and Lot 31, Rancho Del Sol, Unit 1, Map 12477, as more particularly described in said deeds, copies of which are on file in the office of the City Clerk as Document Nos. RR- 279319-1 and RR- 279319-2, is hereby approved.

2. That the City Manager or his designee be, and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 279319-3 quitclaiming to ROBERT BARCZEWSKI, all of the City's right, title and interest in the open space easements in a portion of Parcels 2 and 3, Parcel Map 12337, as more particularly described in the

quitclaim deed.

3. That the City Clerk is hereby authorized and directed to deliver both deeds, and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
