BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$256,135.00 from CIP No. 46-106.0, Annual Allocation for Sewer Pump Station Restoration, to CIP 41-920.0, Sewer Pump Station No. 43, and that the expenditure, not to exceed \$1,773,365.00, for the restoration of Sewer Pump Station #43, from Sewer Revenue Fund 41506, CIP No. 41-920.0, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
