, be and the same are hereby approved.



BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT 68TH STREET AND IMPERIAL AVENUE; AT "A" STREET AND UNION STREET; AND AT RANCHO HILLS DRIVE AND REO DRIVE.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer of \$93,749.00 from CIP 61-001.0, ANNUAL ALLOCATION - SIGNAL INSTALLATIONS TO ACCOMMODATE SUDDEN CHANGES, Capital Outlay Fund 30245, and \$48,970.28 from CIP 62-001.0, ANNUAL ALLOCATION - HIGH ACCIDENT LOCATIONS, Fund 30245, into CIP 61-002.0, ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS, Capital Outlay Fund 30245, and authorize the expenditure of \$290,000.00 from CIP 61-002.0, ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS, Fund 30245, for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to return excess monies, if any, to CIP 61-002.0.
