RESOLUTION NUMBER R- 279343

ADOPTED ON JAN 27 1992

WHEREAS, on January 1, 1984, the State of California adopted the Urban Water Management Planning Act (the "Act") requiring every urban water supplier providing water for municipal purposes to more than 3,000 customers or supplying more than 3,000 acre-feet of water annually to prepare and adopt an urban water management plan; and

WHEREAS, in compliance with the Act, the City of San Diego (the "City") adopted its first Urban Water Management Plan and Conservation Program (the "Plan") in 1985; and

WHEREAS, the City's current Plan, adopted by the City Council of the City of San Diego on December 11, 1990, is an update of the 1985 Plan and fulfills the five-year update requirement mandated by the Act; and

WHEREAS, on October 14, 1991, the State of California enacted Assembly Bill 11x during the 1991-1992 First Extraordinary Session of the California Legislature, an act to amend sections 10620, 10621, 10631, and 10652 of, and to add section 10656 to, the California Water Code, relating to water; and

WHEREAS, Assembly Bill 11x requires each California urban water supplier to amend its existing Urban Water Management Plan to include an Urban Water Shortage Contingency Plan; and

WHEREAS, Assembly Bill 11x requires that the Urban Water Contingency Plan be submitted to the California Department of


Water Resources no later than January 31, 1992; and

WHEREAS, the City of San Diego is an urban water supplier delivering a daily average of 200 million gallons of treated water to City residents; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to approve, for and on behalf of the City, the City of San Diego Urban Water Shortage Contingency Plan.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to submit the approved Urban Water Shortage Contingency Plan to the State Department of Water Resources by January 31, 1992.
