RESOLUTION NUMBER R- 279344

ADOPTED ON JAN 27 1992

WHEREAS, the City of San Diego Police Department desires to apply for, and if selected to accept and expend, a grant award of fifty-seven thousand, two hundred twenty-six dollars (\$57,226.00) entitled "Missing Children: Field Initiated Programs" from the Office of Juvenile Justice and Delinquency Prevention, under the Office of Justice Programs, and

WHEREAS, the grant award would be used to implement and provide a family group counseling program, called "Home to Stay," for youth which the police department's Juvenile Intervention Program identifies as having run away from home, or who are at high risk of doing so; and

WHEREAS, the program requires a half-time clerical assistant II (city employee) and will hire a consultant to implement and direct the program, and to select and supervise hourly contract counselors in providing the program; and

WHEREAS, the "Home to Stay" program was developed jointly by police department Juvenile Intervention Officers and Consultant, Mary Skrubucha, three years ago, and

WHEREAS, the program was developed specifically to address the needs of youth who have run away and their families, and as such was a valuable and effective referral resource for the Juvenile Intervention Program; and

WHEREAS, due to lack of funding, the program is no longer

available as a resource;

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized to submit the Grant Application Proposal, a copy of which is on file in the Office of the City Clerk, as Document No. RR- **279344**, to the Office of Juvenile Justice and Delinquency Prevention, and he is further authorized to execute the grant proposal program, including any extensions or amendments thereof.

BE IT FURTHER RESOLVED AND AGREED, that any liability arising out of the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the federal government, the Office of Juvenile Justice and Delinquency Prevention, and the Office of Justice Programs disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
