RESOLUTION NUMBER R- 279346

ADOPTED ON JAN 27 1992

WHEREAS, in 1882, Old Town's Father Antonio Ubach successfully petitioned the Sisters of St. Joseph of Carondelet to come to San Diego and establish an educational program for one of San Diego's most diverse residential communities; and

WHEREAS, in that same year, four Sisters from the St. Joseph's Order rented two houses located at Second Avenue and G Street and opened their first school with a student body of 24; and

WHEREAS, over the next 70 years, the Sisters established fourteen elementary and two high schools, including the Academy of Our Lady of Peace; and

WHEREAS, in 1924, the Academy acquired the Vandruff Estate overlooking Mission Valley at Copley and Oregon Streets to serve as the site of the school; and

WHEREAS, throughout its history, the Academy has attracted and educated thousands of young women who have made countless contributions to this community and have proven that a quality education is the best preparation for a meaningful and rewarding future; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby recognize 110 years of academic and athletic

excellence exemplified by the students and faculty of the Academy of Our Lady of Peace.

BE IT FURTHER RESOLVED, that Saturday, February 8, 1992, be and the same is hereby designated as "THE ACADEMY OF OUR LADY OF PEACE DAY" in San Diego.
