
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an amendment to the agreement of December 10, 1990 with Kramer, Chin & Mayo, Inc., for value engineering services required for the City's North Subsystem Projects, under terms and conditions set forth in Amendment No. 1 on file in the office of the City Clerk as Document No. RR- 279350, together with any further amendments or modifications thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the amount of \$336,720, consisting of \$160,270 from CIP No. 42-910.1; \$108,010 from CIP No. 42-910.0; \$31,610 from CIP No. 42-910.8; and \$36,830 from CIP No. 40-910.4; all to CIP No. 45-910.3.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$759,057 from CIP No. 45-910.3, is hereby authorized, solely and exclusively to provide funds for this amendment.
