RESOLUTION NUMBER R-279352

ADOPTED ON JANUARY 27, 1992

WHEREAS, through the adoption of the Weed and Rubbish Abatement Ordinances (O-15174, adopted January 28, 1980 and O-15614, adopted November 16, 1981), the City Council has given the San Diego Fire Department the authority to inspect private properties and to cause owners to clean up and remove overgrown weeds, grass, brush, and/or rubbish and combustible waste; and

WHEREAS, Fire Department personnel have responded to complaints for such violations throughout the year and have noticed property owners a minimum of three times of the existence of hazardous conditions on their properties; and

WHEREAS, sufficient time and notification have been given to the owners who have not complied with the notification to successfully perform cleanup operations on said properties; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the Weed and Rubbish Abatement Ordinances (O-15174, adopted January 28, 1980 and O-15614, adopted November 16, 1981), the properties listed below are declared to be a public nuisance and hereby order these parcels to be abated:

1. 7100 Block Lisbon Street - Parcel # 581-050-01
2. 864 Euclid Avenue - Parcel # 542-562-19
3. Between 3150 and 3164 Martin Avenue - Parcel # 545-612-21
