BE IT RESOLVED, by the Council of The City of San Diego that the low bid of COURTESY CHEVROLET, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for Fifty-four (54) POLICE SEDANS (PASTELS) (1992 Chevrolet Corsicas) at a cost of \$10,248.00 each, for a total cost of \$553,392.00; terms 4% 25 days, plus sales tax, less trade-in allowances as follows:
