BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bid of CALIFORNIA UTILITY EQUIPMENT INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of THREE (3) VAN-MOUNTED AERIAL TOWERS (Reach All Model LM40 mounted on an International 4700 cab and chassis) at a cost of \$91,941.00 each, for a total cost of \$275,823.00; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$298,578.40, from Department No. 8201, Fund No. 50031, Object Account No. 6013, and Job Order No. 88091, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
