APPROVING PARCEL MAP W.O. NO. 910181.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "PARCEL MAP W.O. NO. 910181 being a consolidation of Parcels "A" and "B" of Parcel Map No. 1257, filed in the office of the County Recorder of San Diego County, January 30, 1979, and Lots "I", "J", "K", "L", and Portions of Lots "A", "B", "C", "D", "E", "G" and "H" of Block 24 of New San Diego, according to map thereof by Gray and Johns on file in the office of the County Recorder of San Diego County, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the consolidation shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Market Street, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.


