ADOPTED ON JAN 27 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with METCALF & EDDY, INC., Consulting Engineers, to provide design services and an Environmental Impact Report for the NORTH CITY TUNNEL CONNECTOR, with a phased total contract value of \$964,090 under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 279363, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$301,040 within the Clean Water Program Fund 41509, from CIP No. 46-154.0, South Bay Land Outfall, to CIP No. 42-910.8 NORTH CITY TUNNEL CONNECTOR.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$632,190 from the Clean Water Program Fund 41509, CIP No. 42-910.8, is hereby authorized, solely and exclusively for the purpose of providing funds for the first funding phase of said agreement.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this agreement with tax exempt securities, if circumstances so warrant.
