WHEREAS, Division 30, Part 4, Chapter 2 of the Public Resources Code (California Integrated Solid Waste Management Act of 1989) requires that all Local Enforcement Agencies ("LEAs") for solid waste issues be certified by the California Integrated Waste Management Board ("CIWMB"); and

WHEREAS, each local jurisdiction must designate an LEA, or remand that responsibility to the CIWMB, and make notification to the CIWMB as to the designation; and

WHEREAS, an agreement was approved by Council Resolution No. R-277458, designating the County of San Diego as the City's LEA, for a four-year period and authorizing specific payments during those years for those services; and

WHEREAS, subsequent to that action, the County would not execute the agreement due to contract language issues; and

WHEREAS, County Counsel has revised the agreement and no substantive changes have resulted; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the County of San Diego, Department of Health Services, Environmental Health Services, is hereby designated as the Local Enforcement Agency for solid waste issues in this jurisdiction.
- 2. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an

agreement with the County of San Diego, Department of Health Services, to provide technical inspection services at City Solid Waste facilities, under the terms and conditions set forth in the agreement, on file in the office of the City Clerk as Document No. RR- $\frac{279365}{2000}$, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.
