RESOLUTION NUMBER R- 279390

ADOPTED ON FEB 10 1992

WHEREAS, The City of San Diego, in assistance with the City of Tijuana in Baja California, Mexico, has agreed, with the approval of the International Boundary Water Commission, to accept up to thirteen million gallons per day (13 mgd) of untreated Tijuana sewage into the Metropolitan Sewerage System for conveyance to the Point Loma Wastewater Treatment Plant; and

WHEREAS, the wastewater from Tijuana is introduced into the Metropolitan Sewerage System via an interceptor system adjacent to the Tia Juana River channel; and

WHEREAS, heavy winter storms have caused the Tia Juana River to flow at an extremely high level, and have further rendered the culvert to the interceptor sewer incapable of accommodating regular Tia Juana flows; and

WHEREAS, the rupture of the Point Loma Ocean Outfall, recognized in Resolution R-279384, has compounded the City's present inability to accept sewage flow from Tia Juana; and

WHEREAS, the International Boundary Water Commission requests mutual cooperation between the cities in the maintenance of the interceptor; and

WHEREAS, the above circumstances have resulted in the discharge of untreated Tijuana sewage into the Tia Juana River and ultimately into the Pacific Ocean, posing health and safety concerns on both sides of the international border; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
that the City Manager be and he is hereby authorized to contact  
officials in Mexico to offer assistance in repairing the  
interceptor, and to deploy City Forces for such purpose once the  
Tia Juana River flows subside.


