BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with O'Rourke Engineering Company, for engineering consultant services, as needed, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-27939?, together with any reasonably necessary modifications or amendments thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the amount of \$100,000 within the Water Revenue Fund 41500 from CIP No. 73-083.0, Annual Allocation for Water Main Replacements, to the Water Operations Engineering Program (70830); and is further authorized to transfer the amount of \$100,000 within the Sewer Revenue Fund 41506, from CIP No. 40-920.3, Tecolote Canyon Trunk Sewer Improvements, to the Sewer Operations Engineering Program (70820).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000, consisting of \$100,000 from the Water Revenue Fund 41500, Water Operations Engineering Program (70830) and \$100,000 from the Sewer Revenue Fund 41506, Sewer Operations Engineering Program (70820), is hereby authorized, solely and exclusively to provide funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
