1. BURNS AND SONS TRUCKING, Prime Contractor for Item 1, 10 yard truck, at a cost of \$49.76 per hour and Item 2, 20 yard truck, at a cost of \$56.71 per hour, terms net with options to renew for four (4) additional years at the PUC mandated rate.

2. BUD'S & SONS TRUCKING, Secondary Contractor for Item 2, 20 yard truck, at a cost of \$56.71 per hour, terms net with options to renew for four (4) additional years at the PUC mandated rate.
