WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW, THEREFORE,

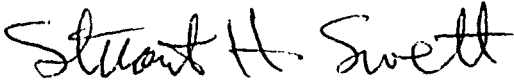

AMOUNT: \$320.00
SUGGESTION: Mr. Obst was a Principal Survey Aide at the time of submittal. He suggested establishing a small library of reference books to make it easier for the members of the survey section to stay current with the requirements of their job. This was considered an operational improvement.

NAME(S): Steven Lagos, John E. Russell and Richard L. Mange
DEPARTMENT: Water Utilities/Metro
AMOUNT: \$317.84 (shared equally)
SUGGESTION: Mr. Lagos was a Marine Biologist I, Mr. Russell and Mr. Mange were Boat Operators at the time of submittal. They suggested using a small stainless steel clip attached to the main cable to prevent losing the messengers when taking water samples. This is a full award based on a savings of \$1,106.28.
