A RESOLUTION FORMALLY RECOGNIZING A COMMUNITY PLANNING GROUP FOR THE COMMUNITY OF EAST ELLIOTT BY APPROVAL OF BYLAWS AND INITIAL MEMBERSHIP.

initial membership to the City Clerk and the Planning Department;
and

WHEREAS, it has been determined by the Planning Department and the City Attorney that these bylaws meet the requirements of Council Policy 600-24; and

WHEREAS, on November 6, 1991, the Rules Committee voted to approve these bylaws as recommended by the Planning Department and that the East Elliott Planning Advisory Committee follow the regular schedule and procedures for conducting business as a recognized community planning group as administered by the Planning Department; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the East Elliott Planning Advisory Committee be formally recognized by the approval of the bylaws, a copy of which is on file in the office of the City Clerk as Document No. RR-279429

BE IT FURTHER RESOLVED, that the East Elliott Planning
Advisory Committee shall follow the regular schedule and
procedures for conducting business as a recognized community
planning group as administered by the Planning Department.
