

RESOLUTION NUMBER R-279429

ADOPTED ON FEB 18 1992

A RESOLUTION FORMALLY RECOGNIZING A COMMUNITY PLANNING GROUP FOR THE COMMUNITY OF EAST ELLIOTT BY APPROVAL OF BYLAWS AND INITIAL MEMBERSHIP.

WHEREAS, it is the policy of the City Council to require each community planning committee, as a condition of official approval by The City of San Diego, to submit a copy of its own operating procedures and responsibilities, otherwise known as "bylaws," to the offices of the City Clerk and the Planning Department; and

WHEREAS, Council Policy 600-24 requires that these bylaws must follow the format of its standard operating procedures and responsibilities and be in conformance with the criteria contained within; and

WHEREAS, Council Policy 600-24 requires that the original bylaws for each community planning committee and initial members and terms of each community planning committee shall be approved by the City Council; and

WHEREAS, a committee wishing to be recognized as the East Elliott Planning Advisory Committee has submitted bylaws and initial membership to the City Clerk and the Planning Department; and


WHEREAS, it has been determined by the Planning Department and the City Attorney that these bylaws meet the requirements of Council Policy 600-24; and

WHEREAS, on November 6, 1991, the Rules Committee voted to approve these bylaws as recommended by the Planning Department and that the East Elliott Planning Advisory Committee follow the regular schedule and procedures for conducting business as a recognized community planning group as administered by the Planning Department; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the East Elliott Planning Advisory Committee be formally recognized by the approval of the bylaws, a copy of which is on file in the office of the City Clerk as Document No. RR-279429

BE IT FURTHER RESOLVED, that the East Elliott Planning Advisory Committee shall follow the regular schedule and procedures for conducting business as a recognized community planning group as administered by the Planning Department.
