
RESOLUTION NUMBER R- 279433

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of CLAIREMONT EQUIPMENT COMPANY, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of SEVENTEEN (17) EACH NON-SYMMETRICAL SCREW TYPE AIR COMPRESSORS at a cost of \$10,584.00 each for a total cost of \$179,928.00; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$194,772.06 from Fund No. 50031, Department No. 8201, Object Account No. 6013, and Job Order No. 88092, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
