WHEREAS, the U.S. Department of Housing and Urban Development (HUD) has issued a Notice of Funding Availability providing that Shelter Plus Care funds are available for rental housing assistance for homeless persons with disabilities (primarily persons who are seriously mentally ill; have chronic problems with alcohol, drugs, or both; or have acquired immunodeficiency syndrome and related diseases); and

WHEREAS, the San Diego Housing Commission has recommended that the City Council authorize the application to HUD for this Shelter Plus Care funding; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council hereby expresses its support of the Shelter Plus Care application and the Executive Director or his designee is hereby authorized to submit an application to HUD for housing assistance for up to 100 participants, the form of which application is on file in the office of the City Clerk as Document No. RR-279436


