BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager or his designee, Maureen A. Stapleton, Assistant City Manager, is hereby authorized to file a grant application including all understandings and assurances contained therein, with the U.S. Department of Commerce, Economic Development Administration (EDA), in the amount of \$1,000,000 for the purpose of obtaining a grant to assist in the funding of the improvements to Crosby Street in the Barrio Logan Redevelopment Project Area. A copy of the application is on file in the office of the City Clerk as Document No. RR- 279453.

BE IT FURTHER RESOLVED, that the City Manager or his designee is hereby authorized and directed to act in connection with the application including, but not limited to, accepting the grant award should the City receive notification from the U.S. Department of Commerce, Economic Development Administration, that its application has been approved and to provide the additional information as may be required.

BE IT FURTHER RESOLVED, that local matching funds of \$1,689,506 to be provided from prior Council authorizations including \$1,000,000 from local TransNet funding per Council Resolution No. R-277701 dated April 15, 1991, and \$689,506 from a

Section 108 loan request to the U.S. Department of Housing and Urban Development per Council Resolution No. R-278798 dated October 8, 1991, is hereby authorized.
