Strobl, et al. v. City of San Diego, et al., for attorneys fees and costs incurred in the suit concerning the "PLAN" initiative.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$25,000.00 made payable to the law firm Gray, Cary, Ames & Frye, attorneys of record for petitioners Strobl, et al., in full settlement of this suit and all claims for costs and attorney's fees or otherwise.
