RESOLUTION AUTHORIZING THE FILING OF AN
APPLICATION FOR FEDERAL AND STATE GRANTS
FOR PUBLICLY OWNED WASTEWATER TREATMENT
WORKS AND PROVIDING CERTAIN ASSURANCES.

BE IT RESOLVED, by the Council of The City of San Diego,
that, for and on behalf of said City, the City Manager is hereby
authorized and directed to sign and file an application for
federal assistance under the Federal Water Pollution Control Act,
as amended, 33 U.S.C. 1251 et seq., and any agreements or other
documents necessary to secure and receive a grant under said act
and a state grant and loan under the Clean Water Bond Laws of
1970, 1974 and 1984 and the Clean Water and Water Conservation
Bond Law of 1978 for construction of wastewater treatment works.

BE IT FURTHER RESOLVED, that the Council hereby agrees and
further does authorize the City Manager to certify that the City
will comply with all applicable state and federal statutory and
regulatory requirements related to any federal or state grant
received, including but not limited to the Assurances contained
in the Federal Grant Application and the State Grant Contract;
the Freedom of Information Act, 5 U.S.C. 552, as amended,
relating to the right of the public to obtain information and
records; the National Historic Preservation Act of 1966,
as amended, relating to the preservation of historic landmarks;
the Copeland (Anti-Kickback) Act, 18 U.S.C. 874, 40 U.S.C. 276c,
and the regulations issued thereunder; 29 C.F.R. 3.1 et seq.;

and the Contract Work Hours and Safety Standards Act, 40 U.S.C. 327 et seq., and the regulations issued thereunder.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute the resultant grant agreements and any amendments thereof for the purpose of securing the grant funds, copies of said Agreements being on file in the office of the City Clerk as Documents No. RR- 279465-1 and RR- 279465-2.
