and the Contract Work Hours and Safety Standards Act, 40 U.S.C. 327 et seq., and the regulations issued thereunder.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute the resultant grant agreements and any amendments thereof for the purpose of securing the grant funds, copies of said Agreements being on file in the office of the City Clerk as Documents No. RR- 279465-/ and RR- 279465-2.
