RESOLUTION NUMBER R- 279466

ADOPTED ON FEB 24 1992

A RESOLUTION DECLARING THE CONTINUED EXISTENCE
OF A STATE OF EMERGENCY RELATING TO THE REPAIR
OF THE POINT LOMA OCEAN OUTFALL.

WHEREAS, on February 5, 1992, the Council of The City of San Diego adopted Resolution No. R-279384 declaring the existence of a state of emergency relating to the rupture of the Point Loma Ocean Outfall; and

WHEREAS, while the City has since entered into emergency contracts to repair the outfall, the nature of the problem and extent of work required to correct it are such that repairs are not now complete, and treated effluent continues to be discharged as recited in Resolution No. R-279384; and

WHEREAS, Government Code section 8630 authorizes local governing bodies to proclaim local emergencies when such events occur as are defined by Government Code Section 8558(c), provided further by said Section 8630 that the local governing body must review the state of emergency every fourteen days until the local emergency is declared terminated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to the requirements of Government Code Section 8630, a continued state of emergency is declared to persist relative to the Point Loma Ocean Outfall.

BE IT FURTHER RESOLVED, that the measures previously taken by said Council in Resolution No. R-279384 shall continue to have full force and effect.
