
ADOPTED ON FEB 24 1992

BE IT FURTHER RESOLVED, that the expenditure of an additional amount not to exceed \$700,000 from CIP 52-356.0 - Route 56/CVREP Acquisition Fund to supplement those funds previously approved by Resolution R-279179 dated December 10, 1991, exclusively for costs related to condemnation of fee and easement interests in connection with the acquisition of approximately 17 additional acres for Route 56/CARMEL VALLEY RESTORATION ENHANCEMENT PLAN PROJECT, is hereby authorized and approved.
