

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to pay the total sum of \$1.490 million from C.I.P. 52-356.0 Rte 56/CVREP Acquisition Fund 790021 for settlement of condemnation proceedings entitled City of San Diego v. Leonard G. Muskin, et al., Superior Court of San Diego Case No. 630079, said \$1.490 million will supplement funds previously authorized by Resolution R-276547 dated September 17, 1990, for the Carmel Valley Restoration Enhancement Plan. (CVREP)

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$1.490 million, made payable to Leonard G. Muskin, Donald T. Leahy, Driscoll and Peterson, in full settlement of the lawsuit and of all claims.


