BE IT RESOLVED, by the Council of The City of San Diego that the low bid of EL CAJON FORD, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE HUNDRED AND FORTY-TWO (142) POLICE PATROL CARS (1992 Ford Crown Victoria) at a cost of \$11,924.00 each, for a total cost of \$1,693,208.00; terms net 30 days, plus sales tax, less trade-in allowances as follows:
