- \$128,905 from Fiscal Year 1993 appropriations contingent on approval of the FY 1993 CIP budget
 - \$ 3,020 from Fiscal Year 1994 appropriations contingent on approval of the FY 1994 CIP budget
- \$ 36,255 from Fiscal Year 1995 appropriations contingent on approval of the FY 1995 CIP budget
- \$ 25,180 from Fiscal Year 1996 appropriations contingent on approval of the FY 1996 CIP budget

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
