BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Metcalf & Eddy, for professional consulting services to provide design services in connection with the East Mission Bay Pipeline (North), under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 279491, together with any reasonably necessary amendments or modifications thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$561,655 from the Clean Water Program Fund (41509), CIP No. 40-910.4, East Mission Bay Pipeline (North), is hereby authorized to provide funds for this project, in the following manner:

- \$368,295 from Fiscal Year 1992 appropriations
- \$128,905 from Fiscal Year 1993 appropriations
contingent on approval of the FY 1993 CIP budget
- \$ 3,020 from Fiscal Year 1994 appropriations
contingent on approval of the FY 1994 CIP budget
- \$ 36,255 from Fiscal Year 1995 appropriations
contingent on approval of the FY 1995 CIP budget
- \$ 25,180 from Fiscal Year 1996 appropriations
contingent on approval of the FY 1996 CIP budget

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
